STATUTORY CONSULTATION LAUNCHED ON THE KEUPER GAS STORAGE PROJECT

I am writing to let you know that Keuper Gas Storage Limited (KGSL) has launched statutory consultation on proposals to develop further underground gas storage in Cheshire. The consultation on the Keuper Gas Storage Project (KGSP) will commence on 2nd October 2014 and close on 27th November 2014.

Subject to feedback received during the consultation period KGSL propose to submit an application for development consent, under the Planning Act 2008, to the Secretary of State for the Department of Energy and Climate Change.

The Keuper Gas Storage Project (KGSP) would see brine extracted from underground cavities at the Holford Brinefield and surrounding area north of Middlewich, Cheshire. The cavities would then be used to store natural gas. An existing brine pipeline, which runs from Northwich to Runcorn, will continue to be used to transport brine from the Holford Brinefield to INEOS' operations in Runcorn and will not be used to move gas.

I am contacting you as a prescribed consultee under Section 42 of the Planning Act 2008, with whom KGSL is obliged to consult on the proposals. As part of this statutory consultation, we have published a number of documents which provide further detail on the proposed development and will aid responses to the consultation.

You will find enclosed:

- **Preliminary Environmental Information Report (PEIR)**
The PEIR provides results from KGSL's preliminary assessments and is presented in CD format, including a Non-Technical Summary of the PEIR. Hard copies are available on request.
- **Project Newsletter**
This community newsletter has been circulated to stakeholders and residents living around the development sites and contains information about the proposed development and contact details for the Project Team.
- **Section 48 Public Notice**
A copy of the Public Notice, published in accordance with Section 48 of the Planning Act 2008, which has this week appeared in The Guardian, The London Gazette, The Northwich Guardian, The Runcorn and Widnes World and the Runcorn and Widnes Weekly News.

KGSL is seeking your views on the PEIR as part of consultation on the application. All responses on the enclosed PEIR must be returned by no later than **Friday 31st October 2014.**

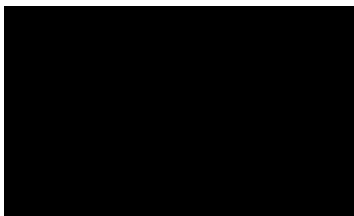

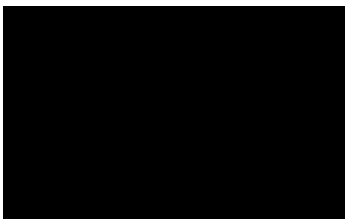
